Generally, a citizen of a foreign country who wishes to enter the United States must first obtain a visa, either a nonimmigrant visa for a temporary stay, or an immigrant visa for permanent residence. Visitor visas are nonimmigrant visas for persons who want to enter the United States temporarily for business (visa category B-1), for tourism (visa category B-2), or for a combination of both purposes (B-1/B-2).

More than 75 million people visit the United States every year, and if you want to be one of them you need to get a B-2 tourist visa. With this visa, you can go sightseeing, visit family or friends, or just rest. Apply online and submit all required supporting documents. Your tourist visa is good for six months.

B-2 Visa Application Process The best place to apply for the visitor visa is the American Embassy or Consulate that has jurisdiction over their permanent residence. While any U.S. consular office can issue a visitor visa, it might be more difficult to obtain a visa from any Consulate office outside their permanent residence.

The B-2 visa is for travel that is recreational in nature, including tourism, visits with friends or relatives, medical treatment and activities of a fraternal, social or service nature. Often, the B-1 and B-2 visas are combined and issued as one visa: the B-1/B-2.
